Red, White and Blue

Red Tudor Rose

A symbol of unity, the Tudor rose (representing the end of the 40-year struggle for possession of the English throne known as the War of the Roses) is supported by the crosses of St. George and St. Andrew as they are depicted on the Union Flag of 1707. The Tudor rose consists of the larger red rose of Lancaster with the smaller white rose of York impressed upon it—five petals upon five petals. In 1584 the first English colony in North America was claimed in the name of Queen Elizabeth I of England, the last Tudor monarch.

NATIONAL HISTORIAN, Ms. KELLY CAREY

This officer is responsible for historical marker approval and guidance. As a reminder they may be used to mark an historic or event site, building, trail, etc. Use of such an efficial marker must be compatible with the objective of the Society which is to commemorate the events of the American Colonial Period (1607-1775). A State Society wishing to place a marker bearing the official insignia shall first request permission from the National President and the National Historian. After approval is received, the order can be placed directly with the dealer who is authorized by the National Society.

This officer asks for your help in creating a list of historical markers which your state society has marked in the past. Please forward any list to this officer so we can add it to the website.

The most rewarding part of the office of National Historian is to present the award for Outstanding American History Teacher. This officer thoroughly enjoyed reading the entries, discussing the candidates with the judges and determining the winners. Please consider nominating someone for this award next year as this is a very visible way for us to gain recognition for the National Society.

Now to present the winners of the Outstanding American History Teacher Award. State Societies may nominate an individual for: "Outstanding service by the exemplification and encouragement of Patriotism and interest in American History and in our American Heritage". Teachers in elementary, secondary, intermediate, high schools and colleges are eligible, as well as leaders of youth organizations, who promote the study of American History. This year's winner is truly an exceptional history teacher. Claiborne Skinner, Ph.D. has been teaching History at the Illinois Mathematics and Science Academy since 1993. He has long been fascinated with the Colonial Period and is the author of four books on the subject including "The Upper Country: French Enterprise in the Colonial Great Lakes". His students built a diorama of Fort Saint Louis as it looked on the morning of February 28, 1684 prior to the siege by the Iroquois. This diorama is a key attraction of the visitor center at Starved Rock State Park in Utica, IL with over 2.5 million visitors annually. It is with great pleasure that I ask Linda Mizell to come forward and accept this award for Professor Skinner. We had five other very deserving nominees and I am pleased to have a certificate for each of those nominees. Will the State Presidents of North Dakota, Kansas, Washington, South Carolina and Texas also come forward to accept the certificates for your state winners?

To encourage member support, this Chairman prepared a letter describing the projects for our Society's national website and The Tudor Rose Councillor.

In addition, this Chairman was asked to prepare a series of feature articles and photos on each of the projects for The Tudor Rose Councillor. Two such feature articles have been published in the past year: The Virginia Historical Society was featured in the Summer 2014 issue of our national magazine, and Jamestown was featured in the Winter 2015 issue. This Chairman is grateful for the work of the editor of The Tudor Rose Councillor in promoting our National Projects.

It is this Chairman's honor to present National Project Leadership Awards to the state societies making the most generous contributions to each of the four National Projects. For 2014, the state societies receiving awards are:

- Connecticut for leadership support of the Cathedral of the Pines.
- North Carolina for leadership support of both Jamestown Rediscovery and the Earl Gregg Swem Library at the College of William and Mary, and
- Illinois for leadership support of the Virginia Historical Society.

TUDOR ROSE COUNCILLOR, VALERIE LASKOWSKI

This chairman has edited, published and delivered two issues of The Tudor Rose Councillor (TRC). As the editor, I have had the wonderful opportunity of meeting members of NSDCW scattered throughout the United States, which I would not have been able to do otherwise.

The challenges of the position are mainly two-fold. First, the post office's rules of distribution of bulk mail processing, and second, the maintenance of the membership address spreadsheet and the addresses which appear in the TRC. Since we are publishing the magazine on the website as a PDF file, everyone has access to it. All of the necessary forms, officers and committees lists within the newsletter are already published on the website; which only leaves featured articles and state articles.



Addressing the first issue, a possible solution would be to have members pay a subscription fee if they want the physical TRC mailed to them, similar to other organizations. I would suggest a yearly fee of \$15.00, which would then consist of two issues per year. This would also allow us to mail the TRC via First Class postage in order to have it arrive in a timely manner. Many of our sister organizations have already instituted this process. The ones that have not, have increased their dues to cover the costs, which is not very transparent to the membership. A "yes or no" field would be added to the membership spreadsheet; and then those "yeses" would be extracted for mailing. Those who do not subscribe can view and/or download the TRC from our member's website.

In regards to the updated membership addresses appearing in the TRC; that is not the responsibility of the TRC editor. The reports are submitted via the national officers and committee chairmen and are "cut and pasted" into the TRC. Only cosmetic changes are done to these reports (such as paragraph justifying and font type and sizes); the content is printed as submitted. I would recommend that the officer in charge of these corrections add the TRC editor to her distribution list of membership changes so they are received in a timely manner in order to update the contents of the TRC.

FILED REPORTS OF THE STATE PRESIDENTS:

KANSAS, REBECCA GEOFF GEIST KLINE

The regular meeting for the Society of Colonial Wars in the State of Kansas was held in Topeka, Kansas in November 2014 with six members in attendance, and the Annual Meeting was held in conjunction with the United States Daughters of 1812 in Wichita, Kansas on March 6, 2014. A fifty dollar donation was sent to the newly established Women's Center at the Dwight D. Eisenhower VA Center, Leavenworth, Kansas. The Women's Center, an outpatient department, will assist women veterans with physical and mental support. A prospective member Christine Leddon was invited to join the state society. All of the national projects were supported, and dues were sent for 23 members. Keil Hileman's application for the American History Teacher award was submitted to the National Historian. Exploration for joint meetings with other lineage societies are continuous to keep DCW viable in Kansas.

MICHIGAN, GRACE ELIZABETH BLISS SMITH, Ph.D.

The Michigan State Society meets three times a year during spring, summer, and fall. The Society has 44 members with five approved in 2014 and five prospective members.

At each meeting of the Michigan Society, two or three members present information in biography format about their patriot ancestor. The purpose of the activity is to keep the memory of these patriots alive in our hearts and to share information about them.

Recently, members were given a "pop-quiz" concerning the colors of the society, its motto, scripture, and goal, the years the national and state societies were established, and the Michigan society's first president. Members enjoyed this activity and asked for others to challenge them.

Discussions have focused on whether the society should expand its public relations in order to attract new members, whether each meeting should have a program speaker, and whether the Michigan society should archive its documents and scrapbooks with the Archives of Michigan as the repository. Along with a "word-of-mouth" approach, members favor press releases and distributing society brochures at meetings of similar hereditary societies. They also favor hosting a program speaker at 50% of the meetings and presenting a pop-quiz or challenging game format about the society or one of its aspects at 50% of the meetings. Members are very interested in the Archives and desire a meeting with a Michigan archivist in July to determine whether our small collection should be included in the materials archived at the State Library.

COMMONWEALTH OF PENNSYLVANIA, MRS. RICHARD CASPAN

The Pennsylvania State Society has 15 members. We have been diligently working to increase our membership with two prospective members.

Members support the President's projects with donations. We also support local veterans at the Shepherd's Heart Veterans Home in Pittsburgh, Pennsylvania. The home provides housing for up to 15 veterans at a time.

Our August 2014 program continued with our theme, "Honoring our Ancestors". This President gave a brief summary of her trip to Milford, CT to celebrate the 375th anniversary of the founding of Milford, and to view for the first time a stone on the Memorial Bridge naming her gateway ancestor, Henry Botsford, as one of the founders in 1639. A total of 54 memorial stones were installed on the bridge. In addition to honoring early settlers, the Memorial Bridge pays tribute to two early governors from Milford, Jonathan Law and Robert Treat. Robert Treat being an ancestor of our



Recording Secretary, Gwen Glasbergen. This President also enjoyed meeting new cousins at the Botsford Reunion, and touring the Botsford family homestead. The homestead was built in 1822 on land originally owned by Henry Botsford and has always been in the Botsford family.

To pay tribute to Honorary National President Mrs. Stanleigh Swan who passed away in December 2014, our members have donated \$100.00 to the National Society in her memory.

It has been an honor to serve as Pennsylvania State President.







Patriots' Day: September 11, 2015 National Chaplain, Mrs. Gary L. Shattuck



George Washington's Farewell Address appeared in Philadelphia's "American Daily Advertiser" on September 19, 1796, almost 205 years before the infamous day of 9-11, today known as "Patriots' Day". Originally, Patriots' Day was proclaimed to be April 19, 1894, by the states of Massachusetts, Mainc and Wisconsin, to commemorate the Battles of Lexington and Concord in the American Revolutionary War. Later Florida joined in that celebration. That original observance has been of continuous commemoration on or near April 19th in Lexington and in Concord; and, joining in continuous recognition since April 1897, is Boston with the Boston Marathon, now, another day of infamy. Then, after "9-11" in 2001, the remaining states joined in this commemoration called "Patriots' Day" commemorated on September 11th in recognition of American Patriots. Surely, George Washington's actions as commander-in-chief of the Continental Army, and his actions during his two terms as the first president of the United States of America, qualify Washington to be among the first American Patriots. Even in his Farewell Address, when he said, "...choice and prudence invite me to quit the political scene, patriotism does not forbid it..." he was saying he was keeping his patriotism for America for life; and so, we, too, should keep our patriotism for America for life. How prophetic are Washington's words when read today, in his own handwriting, in his Farewell Address where he offers patriotic advice, not only to his "Friends and Citizens," but, in the current day as well, to all Americans of all ages, so that we would have his words to rely upon to console us long after he was no longer leading us. So important was Washington's patriotic message to himself to be imparted from his heart, that, for the exact phraseology, Washington relied heavily upon the words of Thomas Jefferson, and the upon the editing of Alexander Hamilton, to phrase the message as Washington intended the message to be phrased. So important was Washington's patriotic message to himself to be acceptable to Jefferson and to Hamilton, that Washington instructed them to remove any "bitterness" from Washington's draft in hopes that "this resolution [will be taken by the citizens with a strict regard to all considerations appertaining to the relation which binds a dutiful citizen to his country". Today, what is of profound significance in Washington's admonitions to us as we honor "Patriots' Day" on September 11th, is his prayer of hope concerning the "perplexed and critical posture of our affairs with foreign nations". With his mature reflection upon his experience gained through the years toward his "sentiment of duty and propriety," Washington felt that with these words, citizens could have the "good intention" to continue following his "infallible...judgment". Therefore, let it be our good intention to heed his warning. So, first, let us begin by saluting our State Societies of Massachusetts, Maine, and Florida, whose states first recognized "Patriots' Day" in remembrance of the American Revolutionary War when some of our first American patriots served the colonial cause inspired by the prayers of General Washington's first National Chaplain. Then, second, let us salute our State Chaplains who report how they have intended, in the present day, to find appropriate times for words of hope and of inspiration.

Let us pray:

Dear Heavenly Father, please accept our appreciation for the services offered by our forefathers, by our ancestors, and by today's patriots who span the ages into today's age of uncertainty. We know each era of patriots hoped to provide a social structure for all to enjoy throughout our entire lives. Also, help us to heed George Washington's cautioning us about dangerous influences of unfamiliar powers so that we may experience that peace which will be neither foreign to our nature nor which will be foreign to our civility. Our prayer, therefore, our Father, is based upon individual concerns for our community, and, also, is based upon collective concerns for our country. Today as we honor our patriots on "Patriots' Day," we pray that you are with each of them every step of the way into the unknown so that they will experience guidance to accept that duty which will sustain them and which will guide them into noble causes that leads toward happiness for all. In your Holy name we pray. Amen.


NATIONAL PROJECTS:

THE EARL GREGG SWEM LIBRARY AT THE COLLEGE OF WILLIAM & MARY

The modern exterior and computer-filled first floor of the College of William and Mary's Earl Gregg Swem Library building belie the extensive Special Collections of historic material that resides within its archives. Assembled from gifts of materials and strategic purchases over the 320-plus years of the College's existence, Special Collections boasts over 50,000 volumes of Rare Books, 1,500,000 Manuscript Items, and the College's Archives that date back to its founding in 1693.

Dr. Earl Gregg Swem, for whom the Library is named, was the Librarian at the College from 1920 to 1944, having worked previously at the Library of Congress and the Virginia State Library. During his tenure at the College, Library collections grew more than ten-fold and reflected his interest in local history and genealogy. Dr. Swem is renowned among genealogists for his four-volume *Virginia Historical Index* — an index of family history data culled from selected Virginia journals and published records. Sadly, Dr. Swem died in 1965, the year before the current library building named for him was completed.

The chief focus of the Swem Library's Rare Book Collection is American history, and the Collection supports the needs of graduate students in history at the College of William and Mary, research at the affiliated Omohundro Institute of Early American History and Culture which resides on the campus, the research needs of other Early Americanists, all of whom are able to use the Library's extensive collections, and undergraduate instruction. The Library's Virginia Rare Book Collection includes early pamphlets of the Virginia Company of 1609, landmark histories of the colony, and publications of the 18th century Williamsburg press.

Rare Book Collections also include complete libraries donated by Virginia families and books dating back to the 15th century, as well as some surprises -- the second largest collection in the United States of books on dogs (over 10,000 items) and over 700 books with fore-edge paintings – paintings on the edges of the leaves of a book that are visible only when the pages are fanned.

Swem Library's Manuscript Collections are focused on American history and Virginia culture. Included therein are Virginia family papers from the colonial period, local county records, military and political papers, newspapers, music, maps, and artifacts.

A recent notable gift is the collection of the papers of Chief Justice Warren Burger which will become available for public researchers in 2026. The Library has created an exhibit of Justice Burger's office and also displays his personal robe worn when he served as Chancellor of the College from 1986 to 1993.

On display in a special open-air gallery within the Swem Library is the treasured statue of Lord Botetourt, Royal Governor of Virginia from 1768 to 1770. The statue is an important early example of publicly-commissioned art and it stood in front of the Wren Building on the College's campus from 1801 to 1958 until it had to be stored indoors to protect it from the elements. When the new Swem Library building was opened in 1966, the original statue was placed in a special gallery in the Library. A replica was created and installed out-of-doors in 1993.

University Archives are the third major element of the Swem Library's Special Collections and include treasures such as the bursar's book that reflects Thomas Jefferson's account as a student at the College.









2015 National Historic Research and Preservation Alan Gallay, Ph.D.



Dr. Alan Gallay teaches and researches in the fields of Early American and Atlantic World History. He is the **2015 National Historic Research and Preservation Winner** for the National Society Daughters of Colonial Wars and was sponsored by the **Texas State Society**. He received his B.A. from the University of Florida, and the M.A. and Ph.D. from Georgetown University. He has taught at several universities, including Notre Dame, Mississippi, Western Washington, Harvard, Auckland (New Zealand), and Ohio State; where he held the Warner R. Woodring Chair in Atlantic World and Early American history, and served as director of The Center for Historical Research.

Dr. Gallay currently holds the Lyndon B. Johnson Chair in U.S. History at Texas Christian University in Fort Worth, Texas. Prior to coming to Fort Worth, he served as J. William Fulbright Lecturer in Colonial American History for the University of Auckland in Auckland, New Zealand, won an Andrew Mellon Foundation Fellowship at Harvard University, and twice was a recipient of fellowships from the National Endowment for the Humanities.

Dr. Gallay's specialty is Colonial American and Southern history and he has published six books and dozens of essays. His most recent book is *Colonial and Revolutionary America: Text and Documents*, addressing the evolution of Colonial America through globalism,


migration and interactions of culturally diver peoples along with the opportunities and obstacles they faced. He has two of his books being republished: Colonial Wars of North America, 1512-1763: An Encyclopedia and Indian Slavery in Colonial America. He is best known for his book on The Indian Slave Trade: The Rise of the English Empire in the American South, 1670-1717 (Yale University Press), which won the Bancroft Prize (the most prestigious book prize in academia in American history), the Washington Center for the Book Award, Choice Magazine Award, and selection by Library Journal as one of the 10 most important books about American Indians published in the previous thirty-five years.

Dr. Gallay brings the 17th century to life for his students touching on areas of early colonial America that is often left untouched. He has served as a public presenter and commentator around the world. In May 2011 and 2012, he served as the Study Tour Leader for Smithsonian Journey, delivering four lectures on colonial America and providing educational leadership for the tour of Chesapeake Bay.

Gallay's current research project is for a book titled, "Raleigh and the Origins of English Colonialism". This work documents the convergence of religious, economic, political, military, cultural, and scientific forces that led England to colonize overseas in the 16th century.


Dr. Skinner is an instructor in the Department of History and Social Sciences at the Illinois Mathematics and Science Academy. He is the 2015 National Winner Outstanding American History Teacher for the National Society Daughters of Colonial Wars and was sponsored by the Illinois State Society. Dr. Skinner earned a Ph.D. in American History, with Distinction, from the University of Illinois at Chicago in 1991 and an M.A.T. in American History from the University of Illinois at Chicago in 1985. In 1977 he earned a Bachelor of Arts in Early Modern European History at the University of Chicago. Dr. Skinner is a member of Kappa Delta Pi Honor Society.

Certifications and qualifications include Illinois State History-Social Studies Teacher K-12; Special Education Instructor; and Secondary High School instructor in American History and Social Sciences. At the college level Dr. Skinner is certified in Western Civilization and American History as well as Canadian History, Military History and Native American Studies. Dr. Skinner has authored four publications which include:

Early French-Canadian explorers captured Dr. Skinner's interest at a young age. He spent time canoeing the Canadian routes of the old Frenchmen. He grew up in St. Louis, MO and Chicago, IL, both important areas to the French Empire. He spent some time in St. Genevieve, MO and near the Straits of Mackinac, MI, again both important to the early French settlers. Working on tug boats on the Mississippi and Illinois Rivers emphasized the critical role these rivers played in colonial history and the fight to gain control of them.

In 1682, La Salle built Fort Saint Louis at Utica, IL to restore French prestige in the region and block another Iroquois invasion. The current Starved Rock State Park in Illinois is on the site of Fort St. Louis and the Great Village of the Kaskaskia. Working with primary documents describing the fort and the battle, topographic maps and secondary sources, Dr. Skinner directed his students to build a scale model of the fort and surrounding landscape as it would have looked on the morning of February 28, 1684. The project took four years and involved over 100 students. The 4'X6' diorama was delivered to Starved Rock State Park in February 2000. Two years later, when a new visitor center opened, the Illinois State Historic Preservation Agency recommended that the fort be included in the Center's interpretive display. The diorama was appraised as a \$10,000 charitable donation to the center. Starved Rock State Park was voted the # 1 attraction in the state of Illinois and receives over 2 million visitors annually.

Dr. Skinner and his students have worked on cataloging colonial battle fields in Illinois. While making trips throughout the state they identified sites from the Iroquois and Mesquaki Wars as well as probable sites for camps and battles. He recently chaired a session at a history conference commemorating the 250th anniversary of the founding of St. Louis held at the Saint Louis History Museum. In 2015 he hopes to revise another book manuscript, *The Canoe Men: Indians, Frenchmen and Empires* for publication.

Topic: "Facts about Washington and His World"

One may not think of teeth when the name, "George Washington," is spoken, but Washington's dental problems have actually made a significant impact on his life and history.

Toothaches began to trouble Washington when he was in his twenties. At 24, he wrote in a diary that he had paid five shillings to "Doctor Watson", who pulled one of his teeth. Washington wound up having several teeth pulled throughout his life, and kept most of them. These teeth were later built into his dentures. In 1760, Captain George Mercer wrote of Washington, "His mouth is large and generally firmly closed, but which from time to time discloses some defective teeth". Eventually, in the mid-1780's, he had a "tooth transplantation" procedure.

Of the many letters Washington sent to his dentist in Philadelphia, one of these letters was lost during its transportation and fell into the hands of British commander Sir Henry Clinton. The letter had requested "one of your scrapers as my teeth stand in need of cleaning". Washington also claimed within the letter that he had "little prospect of being in Philadelphia anytime soon." After reading this letter, the British high command was sure that the American and French forces encamped around New York City would not be marching south to Yorktown to threaten Lord Cornwallis' command. This was a false assumption, as Clinton was not aware that Washington and Rochambeau had just made their plans to move south to trap Cornwallis. Clinton then failed to rescue Cornwallis, which left the British completely defeated at Yorktown on October 19, 1781. Amazingly, much of this defeat can be owed to George Washington's poor dental hygiene, as well as the inadequate mail service of the time.

In 1789, the year that Washington was inaugurated as the first president, he had only a single natural tooth left in his mouth. During this year, Washington also received his first set of dentures. It has been rumored over the years that Washington's dentures were made of wood. In fact, Washington owned several pairs of dentures throughout his lifetime, and while many of them took on a wood-like appearance, they were constructed mostly of materials such as bone, hippopotamus ivory, lead, and even human teeth.

Other people could clearly notice Washington's use of dentures. Senator William Maclay of Pennsylvania wrote about Washington in 1789, "His voice hollow and distinct, owing, as I believe to artificial teeth before his upper jaw." Today, one can still view the effects of Washington's dentures on his physical appearance by looking at Washington's portraits painted by Gilbert Stuart. Stuart was an artist who painted three portraits of Washington in 1795, each showing how his poorly fitting false teeth altered his mouth.

While George Washington's teeth certainly did not make him the famous hero that he was, his dental problems were an important part of his life, and they are one of many things that people will continue to remember about Washington forever.




Class of 2015 Graduation Awards Ceremony, Thursday May 21, 2015




An interesting fact: Lt. Col. Lofland is the only female instructor for JROTC in the state of Connecticut.







We have four new members and two new transfers to North Carolina giving us a membership of 50. Everyone is enjoying a great summer in the South and looking forward to a great meeting in October.







Pages for MAC: Please save as one of these extensions: .doc, .doc, or .txt

PHOTOS:

- 1. Please submit all photos as an email attachment. If using Microsoft Outlook, select "Option->HTML" format so that the photo is attached and not embedded. The original photo must be submitted. Do not make any changes to it or try and convert it to black and white yourself.
- 2. All photos must have a caption. Please submit a simple text file containing the name of the photo it pertains to, along with the names of the people in the photo.

SUBMISSION INSTRUCTIONS:

ALL SUBMISSIONS MUST BE EMAILED, NO "SNAIL MAIL".

Most of your email providers do not allow emails larger than 10MB. If you have more than two photos, this may exceed your limitation. There are two workarounds for this: 1) sending multiple emails, or 2) sending a compressed file. The first option is self explanatory.

To send a Windows Compressed File (.zip):

- 1. Create a folder and place all of your photos in this folder.
- 2. Next, select all of the files in the folder (EDIT->SELECT ALL OR CTL+A).
- 3. Finally, right click and select: SEND TO-->COMPRESSED (ZIPPED) FOLDER.
- 4. This will create a .zip compressed folder (folder with a zipper on it) in your current folder.

Now, create an email and make sure to include your three attachments:

- 1. the article file,
- 2. the .zip file with the photos, and
- 3. the caption file listing all of the photos and their captions.

IMPORTANT: Put "DCW TRC" in the subject line of your email.
